## Notable Matters

Won complete defense verdict in a federal jury trial for Pentius, LLC, a consumer-credit fintech company, on industry incumbent ConsumerDirect's trademark, false designation of origin, and intentional interference claims following a nearly two-week trial and just a few hours of deliberations.

Successfully obtained dismissal with prejudice on behalf of two British agencies that regulate the practice of law in the United Kingdom against broad-ranging RICO, defamation, and other claims brought by two disbarred British solicitors in federal court. The decision was affirmed on appeal and followed by a memorandum decision by the Ninth Circuit Court of Appeals, completing an appellate sweep.

Won summary judgment on a multi-million dollar breach of contract claim brought by a government subcontractor in federal court.

Secured complete dismissal of a consumer protection class action brought against a software and medical device company in Arizona Federal Court against claims of unjust enrichment, economic harm, and violations of the California Unfair Competition Law.
