Bird Marella Wins for Plaintiffs in Southern District of New York Bench Trial

Bird Marella partner [Oliver Rocos](#) and senior associate [Darren Patrick](#) won a contractual dispute in a bench trial in the Southern District of New York on behalf of their third-party logistics company client, which services apparel and home furnishings retailers nationwide.

The case began as a relatively minor disagreement over the appropriate storage rate, but quickly escalated into a hard-fought dispute involving more than \$1 million in warehousing charges tied to goods valued between \$5 million and \$10 million. The defendants further asserted counterclaims valued at over \$15 million.

In a ruling issued this week, the court awarded Bird Marella's client over \$1.6 million in damages. Mr. Rocos and Mr. Patrick also successfully defeated all the defendant's counterclaims.

In the 2025 issue of the prestigious California Lawyer of the Year (CLAY) Awards, the *Daily Journal* honors lead counsel Mr. Lincenberg and co-counsel Mr. Landman for their notable legal defense work in the three-month San Francisco jury trial of *USA v. Gary Lincenberg Named Finalist for Attorney of the Year at 2025 California Legal Awards

Name partner Gary Lincenberg is one of three finalists for Attorney of the Year at the 2025 California Legal Awards.

Mr. Lincenberg is being recognized for his historic and monumental victory in *USA v. Michael Lynch and Stephen Chamberlain*, a criminal fraud prosecution relating to Hewlett Packard's \$11 billion purchase of British software company Autonomy. Prosecutors called the case "California's largest criminal fraud trial ever."

In June 2024, following a decade-long, cross-border battle, and three-month jury trial, Mr. Lincenberg and his team won an acquittal on all counts for Mr. Chamberlain. The case was watched closely, with extensive coverage in major publications such as *The New York Times*, *The Wall Street Journal*, *BBC*, and *Law360*. The landmark win was honored as the Most Important Court Case of the Year at the 10th Annual *Global Investigations Review Awards* held in Washington, D.C., and as *Benchmark Litigation's* United States Impact Case of the Year. *Benchmark* named Mr. Lincenberg a finalist for Litigator of the Year, *AmLaw* named him National Litigator of the Week, and the *Daily Journal* named him the Top White Collar Lawyer. For more than a decade, *Chambers USA* has ranked Mr. Lincenberg Band 1 in "Litigation: White-Collar Crime & Government Investigations."

The winner will be announced at the California Legal Awards on June 25, 2025 in Los Angeles.

Bird Marella Secures No Liability Arbitration Ruling for Sun Date LLC in Alleged State Insurance Fraud Qui Tam

Bird Marella partner [Ron Nessim](#), with senior counsel [Marc Masters](#), successfully defended Sun Date, LLC, the largest date manufacturer and distributor in the U.S., in a state court insurance fraud qui tam case.

A former Sun Date employee, the Relator in the case, alleged in his state court complaint that Sun Date knowingly made false statements in a worker's compensation filing with the intent to defraud him of benefits and he sought millions of dollars in penalties and assessments. Sun Date's defense was that while certain false statements were made, they were the product of mistake and not fraud. Once the Relator was convinced in discovery that Sun Date's defenses were significant, the parties stipulated to move the case from Superior Court to arbitration with stipulated maximums and minimums for both the award and attorney's fees.

After the February 2025 arbitration hearing, the arbitrator recently ruled that Bird Marella's client had no liability.

Bird Marella Secures Dismissal for South Korean Media Giants in U.S. Copyright Case

Bird Marella partners Timothy Yoo and Christopher Jumin Lee obtained dismissal with prejudice on behalf of South Korean media companies SBS, MBC, MBN, and state-owned bank Industrial Bank of Korea (“IBK”) in a copyright-infringement lawsuit concerning the works of South Korean composer Jae-Ho Lee.

The plaintiff alleged that these Korean companies had infringed his U.S. copyright by making Jae-Ho Lee’s music available on their streaming platforms, or by using them in Korean-language YouTube videos. On March 14, 2025, the Honorable Mark C. Scarsi agreed with the defendants’ argument that uploading music to a globally available website such as YouTube was not sufficient to allow a U.S. Federal Court to exercise personal jurisdiction over Korean defendants, and that the plaintiff’s claims against IBK were barred by the Foreign Sovereign Immunities Act, and dismissed the plaintiff’s claims, with prejudice.

Mr. Yoo and Mr. Lee had previously obtained dismissal of similar claims against Kakao Entertainment, Genie Music, NHN Bugs, TJ Media, Keum Young, MBC, and TV Chosun in 2022, a decision that was later affirmed by the Ninth Circuit Court of Appeals.
