MANAGING PRINCIPAL MESSAGE

We are pleased to present to you our 2020 Year in Review.

2020 proved to be one of the most challenging years in most of our lifetimes. The unprecedented events of last year led to dramatic changes in virtually all aspects of society, in our nation and around the world. During these challenging times, the firm found strength in our exceptional staff and its commitment to our clients and the community. While we had continued success on behalf of all of our clients, this Year in Review highlights the outstanding work performed by our attorneys and staff on behalf of community and public interest organizations in this year of crisis.

At the onset of the coronavirus pandemic, the firm seamlessly transitioned to working remotely, avoiding disruption in daily operations, and maintaining consistent communication with clients while monitoring official guidance from federal, state, and local authorities. Our ability to litigate complex matters at the highest levels, and defend our clients' interests vis-à-vis other private parties and government entities, continued apace. Bird Marella also remained committed to the well-being of its staff, avoiding furloughs and layoffs throughout the entire year.

While we continued to serve our clients remotely, we sought out several opportunities to provide support and aid to the local community through pro bono work and community service. Our attorneys worked closely with clients and city officials to provide COVID-19 testing for Los Angeles County, partnered with nonprofit organizations to save displaced tenants from homelessness, co-counseled with civil rights organizations to improve coronavirus safety measures in federal prisons, and joined city-wide initiatives to provide legal assistance for Angelenos. By the conclusion of 2020, the firm had achieved a 62% increase in pro bono hours over the previous year, with an average rate of 116 pro bono hours per attorney.

The urgency of the social justice movement also prompted new initiatives. To provide solutions and prompt action, firm leadership held virtual meetings to identify organizations with whom Bird Marella could partner to help bring about social reform, and spearheaded a new program to provide mentorship for law students from diverse backgrounds. These efforts remain a central focus of Bird Marella, and we will continue to build on these accomplishments in the new year and beyond.

While 2020 saw significant changes in how the courts administer and try cases, delivering outstanding litigation results for our clients remained a top priority. We obtained high profile trial victories for prominent tech companies and leading manufacturers; successfully transitioned to virtual litigation proceedings and achieved favorable results for financial institutions and automotive makers; and successfully defended national law firms, major league sports teams, foreign entities, high level executives and medical professionals in complex business disputes and government investigations.

For the past 40 years, our firm has thrived by solving complex problems and finding creative solutions for our clients. That experience, coupled with the unwavering spirit and commitment of our staff, helped us continue to deliver results for both our clients and those most in need throughout one of the most turbulent years in recent memory. COVID-19 Testing for L.A. County

With the city of Los Angeles facing an increasingly growing demand for testing at the onset of the coronavirus pandemic, principal Ekwan Rhow worked alongside his client Seegene Technologies, Inc., a South Korean biotech company, and L.A. Councilman David Ryu to fulfill agreements to produce testing kits for L.A. County.

Seegene committed to producing 100,000 tests per week for L.A. County with the first 20,000 kits designated to first responders and medical professionals. The initiative provided much needed aid for county health officials and residents, allowing for faster diagnosis and treatment.

Support for Los Angeles Displaced Tenants

In a case spanning two years, principal Dorothy Wolpert and attorneys from the Inner City Law Center (ICLC) obtained a favorable settlement on behalf of 50 tenants displaced from a South Los Angeles apartment building plagued by housing code violations.

The plaintiffs, many of whom were children, were living in substandard conditions for years and exposed to rodent infestation, fire and electrical safety issues, and gang activity while residing in the building. The tenants also endured harassment, discrimination, and retaliation from the building's management and were ultimately forced out so the owners could demolish the building and build new condominiums.

After several months of mediations, Wolpert and the ICLC secured over \$2 million in damages and relocation benefits as part of the settlement, allowing the plaintiffs to transition to safer housing.

The Inner City Law Center is a nonprofit organization that has advocated for housing policies and provided legal services to prevent and end homelessness in Los Angeles for over 40 years. Wolpert, who has been involved with the organization since 1999, is a former president and currently serves as a board member.

Improved Conditions for Federal Prisoners Amid Pandemic

Bird Marella and co-counsel American Civil Liberties Union (ACLU) partnered with the Prison Law Office to file two class action lawsuits against California federal prisons, Terminal Island and Lompoc, concerning the inefficient measures of prison officials to prevent the spread of coronavirus in both facilities.

Filed on behalf of several prisoners, the lawsuits detailed how overcrowding, unsanitary environments, and lack of preventative measures led to thousands of infections and several deaths, violating the Eighth Amendment prohibition against cruel and unusual punishment. Furthermore, both prisons failed to exercise authority under the CARES Act to transfer high-risk inmates to home confinement to save lives and reduce infections.

In July 2020, Bird Marella obtained a preliminary injunction in the Lompoc class action resulting in the home confinement, compassionate release, or residential reentry center transfer of over 300 prisoners. In the Terminal Island suit, the court made a preliminary finding that serious constitutional violations had been alleged and ordered an expert to conduct an onsite inspection of the prison. The site report confirmed numerous deficiencies in Terminal Island's COVID-19 policies and provided crucial evidentiary support for compassionate release motions brought by individual defendants across the country.

The Bird Marella team was led by principals Naeun Rim, Terry Bird and Dorothy Wolpert, counsel Shoshana Bannett, associates Kate Shin, Christopher Lee, Oliver Rocos, Jimmy Threatt, and lead paralegal Sharon Grisham.

Among its many initiatives were efforts to promote and support local programs focused on improving racial relations and supporting Black, indigenous, people of color (BIPOC)-owned local businesses. In addition, the committee worked alongside firm leadership to create an interactive digital library accessible for all attorneys and staff consisting of educational resources on antiracism, activism, and mental health. Through service, advocacy and education, the Bird Marella Diversity Committee continues to work towards a more equitable society and support reform for those often unheard and underrepresented.

Leadership Council on Legal Diversity

In 2020, over a hundred local law students were paired with mentors.

Social Justice Initiative

Launched in September 2020, the ongoing firmwide program allows firm members to identify and volunteer at charitable organizations focused on promoting diversity, advocacy and equality, with the firm providing billable credit for time devoted to volunteering.
